- III. Change to Broward Charter Contracts

5015- K8

Amend the charter contract to decrease maximum enrollment from 1374 to 1,050 for a reduction in enrollment by 324. We would adopt or update an articulation agreement that would allow us to automatically enroll the students promoted from 5015 to 5791.

5791-6/12

The new charter contract would increase enrollment from 750 to 1074 (this is to reflect the 324 reduced from 5015) and we would add an articulation agreement between 5015 and 5791.

Dr. Cruz made a motion to authorize Christine Jurado, as the board's representative, to negotiate the final changes with the district on the board's behalf and to approve changes in the 5015 and 5791 charter contracts as agreed upon by the district and the board's representative.

E. Gonzalez made a motion to approve the Broward K8 (5015) Intent to Renew letter to the district. Seconded by Dr. Cruz. The motion was approved.
