- I. Approval of Minutes for Regular Board Meeting of February 24, 2020 and Special Board Meeting of March 2, 2020
 - E. Gonzalez made a motion to approve the minutes, seconded by A. Cruz. The motion passed.
- II. Open for Public/Parental Comment (regarding agenda items*)

- III. Consent Agenda Items: Approval of Osceola #0155 & #0161 February 2020 Financials; Approval of Broward #5791 & #5015 February 2020 Financials; Approval of AES Bridge Loan; Acceptance of Broward 2019-20 Title 1 School Wide Plans; Acceptance of Broward 2020-21 School Level Parent Family Engagement Plans (PFEP); AGA 5791 & 5015 Amendment to Charter School Agreement

- IV. Update of School Response to Temporary Closure
 - a. COVID19 Update
 - F. J. Bolanos provided a general update, including that the school closure was extended thru April 30th.
 - b. Osceola
 - G. Moreno advised they started their virtual learning preparations on March 9th and thru the use of ZOOM and Google Classroom today was their first day of virtual learning. It went very well, they had 72% attendance. Conducted virtual teacher walk-thru via ZOOM and the teachers were doing

well. Last week over 700 families picked up learning packets at the school and 200 computers were provided for use at home. All teachers were given Google numbers to use to communicate with parents and students. Very proud of how well all the teachers responded to this challenge and how hard they worked to get prepared for virtual classes.

c. Broward

Dr. Valdes advised it was very inspiring to witness the teacher unity that was demonstrated during this difficult time. The teachers worked all thru Spring Break to ensure they would be ready for virtual learning starting today. Computers have been distributed to students, using USA Test Prep, Google Classroom and teacher websites to conduct virtual learning. S. Walker stated the teachers were very happy with the amount of communication and support received from administration. School website has been updated to provide COVID19 updates and information. Gym bleachers were delivered and installed.

d. Streamline Check Signing Policy During COVID19 Crisis

Due to the social distancing directives and guidelines staff is requesting that
flexibility be granted during the pandemic crisis regarding check signing and
vendor payments requirements.

Dr. Cruz made a motion to allow executive staff with flexibility regarding check signing and vendor payments, during the COVID19 crisis, in compliance with State and Local directives regarding social distancing and stay at home orders. E. Gonzalez seconded the motion. The motion passed.

Valent questioned if a 20-year lease was desirable for the school, at this point in time, with everything that was going on. E.
